## Post-Grad Program Application Instructions 2017-2018

### ALL DOCUMENTS MUST BE SUBMITTED IN ENGLISH

### APPLICATION PROCEDURE

We enroll a limited number of students annually from a pool of qualified applicants, so we encourage all interested student-athletes to submit the application form as early as possible. All application materials must be received by the below deadline dates, before receiving a decision notification. Once applications are received, applicants will be scheduled for an interview. Notifications will be sent by email.

**Early Decision Application Deadline: June 1, 2017**

**Regular Decision Deadline: July 15, 2017**

### APPLICATION PROCESSING FEE

A \$200 non-refundable fee is required to process the application. Payment should be made in the form of Cashier's check, money order or credit card. All checks payable to **Schoolhouse Preparatory**.

## TUITION ENROLLMENT AGREEMENT/DEPOSIT

Once the applicant has been admitted to Schoolhouse Preparatory, a Tuition Enrollment Agreement (TEA) and Financial Worksheet will be sent and must be returned by the date indicated, along with a deposit as described below.

\_\_\_ Students must read and sign the Tuition Enrollment Agreement Form and return to Schoolhouse Preparatory along with a non-refundable **\$3,000** Admission Fee to reserve your space.

## INTERNATIONAL STUDENTS

An International Student is a student who:

- Is attending or has ever attended a non-U.S. sponsored high school or secondary school, or
- Is seeking an I-20 for the purpose of obtaining an F-1 student visa, or
- Currently holds an I-20 from another U.S. institution

## REQUIRED DOCUMENTATION FROM INTERNATIONAL STUDENTS

Schoolhouse Preparatory must receive all transcripts from non-U.S. sponsored high schools or secondary schools. Applicants should also submit records for the year prior to secondary school and national examination scores, if applicable.

## TUITION ENROLLMENT AGREEMENT/DEPOSIT FOR INTERNATIONAL STUDENTS

\_\_\_ Non-US Citizens: Students requiring a new I-20 Form must send an additional nonrefundable **\$1,000** fee along with the non-refundable **\$3,000** deposit, plus proof of finances.

## **INTERNATIONAL STUDENTS MUST SHOW PROOF OF FINANCIAL RESOURCES**

All applicants who will require a Form I-20 from Schoolhouse Preparatory must demonstrate that they have sufficient funds to cover the cost of annual tuition fees, and living expenses.

**The acceptable forms of financial verification include:**

- Bank statements from the past three months, showing regular deposit history
- Letter from Bank (see below)

NOTE: Bank documents must be in English or accompanied by an official English translation. The I-20 will not be issued until Schoolhouse Preparatory receives one of these documents.

## **INTERNATIONAL STUDENTS TRANSFERRING FROM OTHER U.S. INSTITUTIONS**

Upon official acceptance to Schoolhouse Preparatory, students must contact their original institution to request a transfer of their SEVIS/I-20 record to Schoolhouse Preparatory. When the tuition deposit is paid to Schoolhouse Preparatory and proof of financial resources is received, Schoolhouse Preparatory will issue an updated I-20.
